\*Unit occupies 2 floors that are NOT connected by stairs. Movement between floors in the unit is only by way of a 2-person residential elevator. This unit is not suited for travelers with children under 14.

### Unit Amenities

All units are equipped with a 2 burner stove top (**no oven**), microwave, dishwasher, fridge, coffee maker, hairdryer, shampoo and conditioner (single use size), safe (free), TV (**no DVD**), telephone and air conditioning.

The bathrooms are considered 3/4 baths as they have a shower and not a tub. Most of them have 2 doors to access them.

**Views:** All units except the one bedroom townhouse have side views of the ocean from the living room window. The one bedroom townhouse units have a street view only.

**Unit Access:** Due to the age and the structure of the building, some units may not be accessible for guests with mobility issues.

# **Driving Directions**

### Location


Located in the charming island beach village of Lauderdale-By-The-Sea, this beachfront community is neatly tucked into a one mile stretch just north of the City of Fort Lauderdale. This prime spot on Florida's famed Gold Coast presents numerous choices for exciting adventures easily accessible from town.

### From Hwy 95

- Exit airport and follow signs to I-595 West.
- Head west and follow signs to I-95 North.
- Merge onto I-95 North and take Exit 32 onto Commercial Boulevard East.
- Head East until you see the beach sand at El Mar Drive.
- Turn right onto El Mar Drive to 4244 El Mar Drive (1 block).

## Scenic Beach Route (our preferred route)

- Exit airport and follow signs for N. Federal Highway/US1 North.
- Stay on Federal Hwy/US1 and follow signs to "BEACHES" and turn right (East) onto 17th Street Causeway.



 Stay on 17th Street Causeway which will turn into A-1-A after the draw bridge for about 10 miles and make a right on Datura Avenue (1 block South of Commercial Blvd). • We are at the end of Datura Avenue at 4244 El Mar Drive.
